- e) To provide food, shelter, clothing, medical care and education for the needy.
- f) To train and equip the pupils so as to be self supporting in an honourable and decent way of life so as to develop into good, healthy and progressive citizens.

- 1) To become affiliated member of national bodies, federations, international bodies having similar aims and objectives. And the above trust may conduct & organise any kind of programmes mentioned in objects in state, National & International level.
- 4) MANAGEMENT AND BOARD OF TRUSTEES :
  - a) The management of the trust shall be in the board of Trustees.
  - b) The Trust shall be governed by the board of trustees which ordinarily shall consist of not less than five and not more than eleven members. The founder and author of the trust and the other trustees shall hold office for life. The trustees may co-operate to the board of trust to make the total number to eleven.
  - c) The trustees co-opted shall hold office only for three years and are liable for retirement. The Trustees whose term of office expires after the period of three years are eligible to be re-co-opted as trustees again by the existing trustees. The Trustees, may, if he/she so desires resign from his/her trusteeship even before the expiry of the term of his/her trusteeship.
  - d) The trustees shall appoint one or more among them as the managing trustees of the board of trustees. How ever, at present and under this declaration of trust, the trustees

and shall be the managing trustees for life, and after them any persons of their choice either among the rest of the trustees herein or otherwise as may be decided in the case, shall be the managing trustees for life. And any one of the managing trustees shall act as chairman and preside over at all the meetings of the trust.

e) In the event of death of any of the trustees herein, his/her nominee, if any, shall be appointed as trustee, However, the board of trustees containing rest of the trustees shall have all powers either to prefer to the nominee of the deceased trustee, or else, to appoint other person as trustees to replace the vacancy so cause.

f) NOTWITHSTANDING ANYTHING CONTAINED THEREIN, The board of trustees shall be authorised to and fully empowered for removing or disqualifying any of the trustee/s from the board of trustees, if his/her conduct is found faulty and against the interest of the trust, by 3/4<sup>th</sup> majority of the trustees. And any vacancy arising out of death, resignation, removal or disqualification of any of the trustee/s, shall be filled in by all the remaining board of trustees in a specially convened meeting. And the person/s so co-opted in his/her place shall serve the trust in terms of this declaration.

5) POWERS AND FUNCTIONS OF THE BOARD TRUSTEES :

- a) The board of trustees shall have full powers in general to acquire all things and do all acts found necessary to carry out the objects of the trust.
- b) The trust may receive donations of moneys and/or properties when received and the same be at the absolute disposal of the trust.
- c) The trustees shall invest the properties and moneys of the trust in such manner as prescribed under section - 11 of the Income Tax Act, 1961 and other statutory laws. The board of trustees shall meet as often as necessary and then proceedings, shall be recorded regularly in the minute book to be retained for the purpose. In any resolution to be passed touching the administration of the trust, the opinion of the majority shall prevail. It shall be competent however for the trustees to decided any or all matters by circulation.
- d) And in case, there being equality of votes, the chairman of the meeting shall have a casting vote for the purpose of deciding the issue.
- e) The trustees may open one or more banking accounts and operate current or deposit or other such accounts with any scheduled or such other bank/s, will be operated by chairman of the trust, either singly or jointly or severally to operate such accounts.

1. TERMS OF OFFICE:

- iii) The Board of Trustees shall purchase or acquire properties consisting of movables and immovable necessary for carrying out the object of the trust. The Trustees shall take on lease or license or exchange, hire or otherwise acquire any property or any interest therein for the fulfillment of object of the Trust.
- iv) The Board of Trustees may sell or dispose off any moveable or immovable property upon such terms and conditions as the trustees may deem proper or by the President alone.
- v) The Board of Trustees shall invest the moneys of the trust or deposits in scheduled banks, financial institutions by opening an account in the name of the trust and shall be operated with the joint signatures of the Presidents and Secretary. All the bank operations shall be carried by the signature of any two of the said office bearers.
- vi) For the purpose of carrying out the objects of the Trust, the Board of trustees may borrow moneys and raise loans or obtain advances upon such terms and upon such securities as may be determined by them.
- vii) For the purpose of carrying out the objects of the Trust, the Board of Trustees shall be entitled to appoint the required personal and to pay them suitable remuneration/honorariums. They are also entitled to take suitable action to suspend, remove or dismiss any such person so employed, as per law.
